CENTRAL ALBERTA CO-OP "CO-OP WEEK" CONTEST – OFFICIAL CONTEST RULES & REGULATIONS

The Central Alberta Co-op "Co-op Week" contest (the "**Contest**") is sponsored by Central Alberta Co-op Ltd. (the "**Sponsor**"). The Contest begins at 8:00am MST October 15, 2023 (the "**Contest Start Date**") and ends 11:59pm October 21, 2023 (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. HOW TO QUALIFY:
